ITEM 1 Welcome

President Vladimir Lisin welcomed all delegates to the ISSF Extraordinary General Assembly (EGA) in Munich, Germany. He expressed his hope that the Assembly will be constructive and effective.

ITEM 2 Opening of the Assembly

The President gave the floor to Secretary General Alexander Ratner who opened the EGA.

ITEM 3 Roll-Call

The Secretary General established that in view of the members present the EGA has the quorum to take decisions in accordance with the ISSF Constitution.

N.B. The exact roll-call of the Member Federations represented at the EGA follows from the overview table displayed above. Further, for the voting on the new ISSF Constitution the numbers of votes cast and the voting result is set out in detail at Item 10.3 below.

The Secretary General further pointed out that for procedural reasons the appointment of Scrutinizers would be required which would be in charge of counting the votes when decisions are to be taken.

Upon suggestions of the Continental Confederations the following persons were proposed as Scrutinizers:

Upon suggestion of the Executive Committee Kimberly Rhode, USA (Americas) was proposed as chair of the Scrutinizers.

No objection against these Scrutinizers were raised.

After this, a minute of silence was held for the following recently passed away members of the shooting family: Mr Zahid Noori Gatea Al Dubaisi, President of the Iraqi Shooting Federation, and Mr Petr Malek from the Czech Republic, Silver Medalist in Sydney.

ITEM 4 Approval of the Agenda

With regard to the Agenda of the EGA, nobody raised objections to the Agenda as sent out to the Member Federations on 4 October 2019. Therefore, the Agenda was approved and followed accordingly during the EGA.

ITEM 5 Appointment of the Minutes Committee

The Secretary General proposed according to ISSF's long-standing practice as members of the Minutes Committee the Secretary General (in this case, himself) and a representative of British Shooting, (in this case, Mr. Hamish McInnes). When the Secretary General asked for abstentions or votes against this proposal, nobody raised his voting card. Hence, the Minutes Committee was approved.

ITEM 6 Determination of annual membership fees as of 2020

The Secretary General asked the appointed Scrutinizers to prepare for the count of the vote on Item 6 with regard to the determination of the annual membership fee as of 2020 (proposal: reduction from CHF 1,500 to USD 500).

Mr Luciano Rossi took the floor and expressed his appreciation of this proposal from the Executive Committee. He mentioned that at the last General Assembly at Munich the proposal of the Executive Committee was to increase the membership fee, which was opposed by him and others and rejected by the General Assembly with a large majority. He also stressed that the international federation must support the national federations.

The Secretary General thanked Mr Rossi and reminded that the proposal to increase the membership fee came from the previous ISSF leadership, i.e. the then Executive Committee. He also pointed out that in 2019 only 8 Member Federations did not pay the membership fee of 1,500 Swiss Francs. Now it is proposed to reduce the annual membership fee to USD 500.

The Secretary General asked for the vote on the proposal. When the Secretary General asked for abstentions or votes against this proposal, nobody raised his voting card. Hence, the proposal was unanimously approved.

ITEM 7 Proposals to approve changes to Article 3.2.2 ISSF General Regulations

The Secretary General reminded that the decision on this item was postponed from the previous General Assembly to the EGA in order to take the opinion of the member federations into consideration. He explained the main principles behind the change as defined during the last General Assembly: Principal 1: Rifle and Pistol shooters should have the same possibilities as Shotgun shooters for the World Championships. The present procedure of having three World Championships in shotgun and only one in rifle and pistol during the Olympic cycle is not balanced and should be changed so that all disciplines have the same number of Championships. Principal 2: Juniors should have the same number of Championships as Seniors. Principal 3: The system of World Championships should be connected to the system of quota places.

The proposed new wording of Article 3.2.2 ISSF General Regulations was displayed on the screen and read out by the Secretary General as follows:

"Senior World Championships for all events must be organized every four years, two years after the Olympic Games. In other years, with the exception of the year in which the Olympic Games take place, separate World Championships for Shotgun as well as Rifle and Pistol events must be organized. Junior World Championships for all events must be organized every two years in the year of the Olympic Games and the second year after the Olympic Games (even-numbered years). Continental Championships should be organized at least every two (2) years as decided by the respective Continental Confederations."

He noted that if this amended rule is approved, Junior World Championships will be held in 2022, 2024 etc. and separate World Championships in Shotgun as well as Rifle/Pistol events will be held in 2021, 2023, etc.

The Secretary asked the floor if anything remains unclear. As nobody raised questions, the Secretary General asked for the vote on the proposal. When the Secretary General asked for abstentions or votes against this proposal, nobody raised his voting card. Hence, the proposal was unanimously approved.

ITEM 8 Report of the external Auditors for 2018

The Secretary General remembered that in the past some Member Federations expressed concerns regarding a lack of transparency etc. Therefore, the new leadership decided to have an external audit done by an international recognized auditing company in order to avoid any doubts in the correct way of the bookkeeping and any other financial matter of the ISSF. PriceWaterHouseCoopers (pwc) was mandated to make the audit. He pointed out that the report of pwc was part of the delegates' documents and will be presented by the responsible auditor, Mr Dennler from pwc:

Mr Christian Dennler from pwc took the floor and provided information on the audit to the General Assembly. The report of Mr Dennler was followed by applause of the General Assembly.

The Secretary General thanked Mr Dennler for the report and asked for questions.

Mr Lodhi took the floor and expressed his appreciation for this action of transparency and good governance of ISSF's new leadership.

The Secretary General thanked Mr Lodhi and reminded that it was also Mr Lodhi who suggested engaging external auditors in the future. The Secretary General encouraged also other Member Federations to contribute to the ISSF by making proposals in the future.

ITEM 9 Report of the President

The ISSF President took the floor and gave a comprehensive report about the wide range of his activities since the election one year ago. In his report, he particularly pointed out that his mission does not constitute of performing representative functions but in developing the popularity of the shooting sport, expanding the numbers of participants in competitions, attracting the mass audience, especially the youth, fostering the role and the prestige of the national federations and

continental confederations in the Olympic Movement. The President's report was followed by applause of the General Assembly.

Mr Raninder Singh took the floor and informed the Member Federations about the positive outcome of meetings between the representatives of the Commonwealth Games and the ISSF leadership.

The Secretary General asked the General Assembly whether there are any questions to the President.

Mr Robert Mitchell took the floor and pointed out that the President's travel activities were made at the President's own expenses. He thanked the President for his strong work.

ITEM 10 Alteration of the ISSF Constitution

ITEM 10.1 Discussion of the proposed new provisions of the ISSF Constitution

The Secretary General asked Ms Biserka Vrbek, the chair of the ISSF Statutes and Eligibility Committee, to take the floor in order to explain the procedure of the proposed draft of the new ISSF Constitution.

Ms Vrbek took the floor and explained the process of the preparation of the draft of the new ISSF Constitution. She first explained the rationale behind the proposal of the new ISSF Constitution. She in particular pointed out that the current Constitution dates back to the year 1980 and the ISSF needs a modern Constitution which corresponds to the principles set by the Olympic Charter and the good governance principles as defined by ASOIF and WADA. She explained that the new Constitution supports the efforts of small Member Federations to develop the shooting sport in their respective country and also defines clear rights and obligations of the Member Federations in order to differentiate between full members and associated members. Further, Ms Vrbek highlighted that the new Constitution foresees limited terms of office and age limits for individuals. The new Constitution would also increase gender equality within the ISSF. Ms Vrbek then explained the schedule of the creation of the now proposed new ISSF Constitution. She in particular pointed out that in June 2019 the Member Federations were invited to comment on the proposed draft until 25 August 2019 in order to organize a broad discussion on this working. These comments of the Member Federations were afterwards analyzed by the ISSF Statutes and Eligibility Committee. On 3 October 2019, the ISSF Statutes and Eligibility Committee met and discussed the implementation of the proposals based on the comments of the Member Federations. On the following day, the new version of the proposed new ISSF Constitution was sent out to all Member Federations for information with the invitation to provide further comments to the ISSF until 25 October 2019. During the meetings in December 2019, the further comments of Member Federations were considered and implemented into the proposed draft of the new Constitution. After the Continental Meetings further amendments have been made in accordance with the proposals of the Member Federations. Ms Vrbek then gave an overview on the proposals/comments of the Member Federations and the participants of the discussion process. Ms Vrbek highlighted the most discussed provisions of the proposed new Constitution and explained the reasons behind the current draft provisions.

The Secretary General thanked Ms Vrbek and her colleagues for the great efforts. He then asked the ISSF legal advisor, Mr Christian Keidel, to take the floor.

Mr Keidel took the floor and confirmed that the current draft of the new Constitution is the product of an incredible joint effort by the Statutes and Eligibility Committee, the Member Federations and the Executive Committee. He also described the process of evolution of the current draft. Mr Keidel pointed out that he will now guide the General Assembly through the amendments which were made to the draft since it has been sent out to the Member Federations on 4 October 2019. He then went through the current version of the proposed new Constitution which was displayed on the big screen showing amendments in red colour and which had also been distributed to the Member Federations as part of the EGA documents. In the following, he explained the amendments made since 4 October 2019 one by one.

ITEM 10.2 Voting on alternatives of the proposed new provisions of the ISSF Constitution

Mr Keidel further explained that after this long process of discussions and comments the Statutes and Eligibility Committee identified five issues which were still discussed very controversial among the members, namely

- the quorum to request a secret vote,
- the quorum for the request of an extraordinary general assembly,
- the possibility of proxy voting,
- the final instance competent on the decision of a member's exclusion, and
- the competence on the selection of hosts of World Championships.

Mr Keidel explained that the ISSF found that in order to have a proposed draft which best possible corresponds to the opinion of the majority of the Member Federations, it should give the members the opportunity to vote on these controversial issues. Mr Keidel explained that the alternatives will now be made subject to the vote of the General Assembly in order to determine which of the alternatives shall be part of the final proposal of the new Constitution to be voted on under agenda Item 10.3. He further explained that in each alternative to vote on "A" represents the proposal as it is now in the current draft of the new Constitution and "B" represents the provision as it is laid down in the current ISSF Constitution. He once again emphasized that the voting on the alternatives under this agenda item does not change the current ISSF Constitution but shall only determine which of the alternative proposals will be part of the proposed new Constitution made subject to the vote of the General Assembly under agenda Item 10.3.

The Secretary General also confirmed that the voting on the alternatives has nothing to do with the alteration of the Constitution but only determines the final version of the proposed new Constitution to be voted on at a later stage.

The first alternative proposal was displayed on the big screen as follows:

Mr Keidel explained the reason behind the proposal under "A". Subsequently, the Secretary General opened the floor for voting on the alternatives, the General Assembly conducted the vote and the Scrutinizers counted the votes. The majority of the General Assembly was in favor of the provision proposed as "A".

The second alternative proposal was displayed on the big screen as follows:

Mr Keidel explained the reason behind the proposal under "A". Subsequently, the Secretary General opened the floor for voting on the alternatives, the General Assembly conducted the vote and the Scrutinizers counted the votes. The majority of the General Assembly was in favor of the provision proposed as "A".

The third alternative proposal was displayed on the big screen as follows:

Mr Keidel explained the reason behind the proposal under "A". He in particular pointed out that also in other IFs proxy voting was not allowed. Subsequently, the Secretary General opened the floor for voting on the alternatives, the General Assembly conducted the vote and the Scrutinizers counted the votes. The majority of the General Assembly was in favor of the provision proposed as "A".

The fourth alternative proposal was displayed on the big screen as follows:

Mr Keidel explained the reason behind the proposal under "A". Subsequently, the Secretary General opened the floor for voting on the alternatives, the General Assembly conducted the vote and the Scrutinizers counted the votes. The majority of the General Assembly was in favor of the provision proposed as "A".

The fifth alternative proposal was displayed on the big screen as follows:

Mr Keidel explained the reason behind the proposal under "A". Subsequently, the Secretary General opened the floor for voting on the alternatives, the General Assembly conducted the vote and the Scrutinizers counted the votes. The majority of the General Assembly was in favor of the provision proposed as "A".

Subsequently, the Secretary General asked the General Assembly whether there are any other matters of concern within the current draft proposal of the new Constitution on which the General Assembly seeks to vote on. The representative of the Irish Clay Target Shooting Association, Mr Conor Mooney, referred to Article 3.4 of the proposed new Constitution and asked for clarification from the legal advisor. Mr Keidel clarified that the regulation in Article 3.4 of the proposed new Constitution is the same provision as in the current ISSF Constitution (Article 1.3.3). Upon question, Mr Keidel further clarified the new provision on proxy voting. The Secretary General once again explained the reasoning behind this proposed provision and after that announced that the General Assembly will continue with Item 10.3 after the lunch break.

ITEM 10.3 Voting on new provisions of the ISSF Constitution

Subject to the vote of the EGA was the final proposal of the new provisions of the ISSF Constitution as presented to the Member Federations under Item 10.1 and as decided by the General Assembly under Item 10.2.

The Secretary General pointed out that there was a motion to conduct the decision on the alteration of the ISSF Constitution by secret vote. According to the Constitution, a request by at least 20% of the members represented would be required in order to have a secret vote. He pointed out that considering the roll-call 54 votes are required to have a secret vote on Item 10.3 of the Agenda. He then asked the Delegates to raise their green Yes-voting card if they are in favor of the secret vote.

The Scrutinizers counted the votes and informed the Secretary General that there are 134 votes in favor of the secret vote. Hence, the Secretary General announced this number to the EGA and informed the Delegates that a secret vote will be conducted.

The Secretary General showed the delegates the voting card prepared for the secret vote and read out the wording of the following voting card:

The Secretary General also pointed out that every voting card was stamped and bears his signature on the backside. The Secretary General further explained the voting procedure as follows: Each Member Federation will be called one by one and shall come to the Scrutinizers. In exchange to their green voting cards [i.e. their number of votes] they will receive the respective number of voting cards for the secret vote, which had to be put into one of the sealed boxes after the vote.

In the following, the Member Federations were called alphabetically in order to cast their vote. After every Member Federation had been called, the Scrutinizers took the sealed boxes with the votes and went to another room in order to count the votes.

The Scrutinizers' vote count showed the following voting result which was subsequently announced to the Delegates:

2/3 Majority of 262 votes (Article 1.20.2 of the current ISSF Constitution)	at least 175 yes-votes
Yes-votes cast	178

Therefore, the new ISSF Constitution has been approved by the EGA.

The President thanked the Delegates for the support.

ITEM 11 Closing of the Assembly

The President thanked the Delegates for their active participation of the General Assembly gave some organizational instructions regarding the Golden Target Awards Ceremony in the evening organized by the ISSF to celebrate the 12 best athletes of the year. After that, the President closed the Extraordinary General Assembly.
